APPLICATION FOR DIRECT HIRE EXEMPTION FOR HIGHLY-SKILLED/PROFESSIONAL OFWs

<u>Effective immediately</u>, the following shall be observed when applying for **DIRECT HIRE EXEMPTION FOR HIGHLY-SKILLED/PROFESSIONAL OVERSEAS FILIPINO WORKERS**:

<u>STEP 1:</u> Employer shall submit the documentary requirements to POLO Tokyo as listed at the website. (https://polotokyo.dole.gov.ph/direct-hire-skilled-professionals/)

<u>STEP 2:</u> After POLO Tokyo's verification, employer shall apply for Certificate of Eligibility (COE) at the Japanese immigration office.

<u>STEP 3:</u> Employee to apply for Japanese visa at the Japanese Embassy in Manila, Philippines.

<u>STEP 4:</u> Employee to submit complete documentary requirements to POEA for Direct Hire Exemption.

<u>STEP 5:</u> Employee to present Overseas Employment Certificate (OEC) from POEA and valid working visa to airport officials to legally exit the Philippines.
